1. We respect your privacy

- (a) PCD Logistics respects your rights to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out how we collect and treat your personal information.
- (b) "Personal Information" is information we hold which is identifiable as being about you.

2. Collection of personal information

- (a) PCD Logistics will, from time to time, receive and store personal information you enter onto our website, provided to us directly or given to us in other forms (email, etc).
- (b) You may provide basic information such as your name, phone number, address and email address to enable us to send information, provide updates and process your product or service order. 3. How we collect your personal information

Personal Information is only supplied to a third party when it is required for the delivery of our services.
- (b) We may from time to time need to disclose personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warranty, in the course of a legal proceeding or in response to a law enforcement agency request.
- (c) We may also use your personal information to protect the copyrights trademarks, legal rights, property or safety of PCD Logistics, www.pcdlogistics.com.au, its customers or third parties.
- (d) Information that we collect may from time to time be stored, processed in or transferred (only in an encrypted fashion) between services providers located in countries outside of Australia (only for Cloud-based services we utilise for storage and data retrieval and transfer).
- (e) If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our use database, together with any personal information and non-personal information contained in those databases (to the new business owner). This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.
- (f) By providing us with personal information, you consent to the terms of this Privacy Policy and the types of disclosure covered by this Policy. Where we disclose your personal information to a third party, we will required that the third party follow this Policy regarding handling your personal information. Furthermore, we guarantee that the only purpose for the disclosure of this information is in the normal performance of services contracted to us by our clients.

6. Security of your personal information

- (a) PCD Logistics is committed to ensuring that the information you provide to us is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure information and protect it from misuse, interference, loss and unauthorised access, modification and disclosure.
